Governance Committee Meeting Minutes April 27, 2022 3:30 PM

Present: Rodney Reynolds, Brian Wilson, Steve Bass, Scott Barnes, Richard Camp, Janet Holley and Kathy Milam

Rodney Reynolds, Chairperson, called the meeting to order at 3:30 pm.

Minutes from the April 26, 2021 Governance Committee Meeting were approved as presented.

Kathy Milam summarized the materials provided with the meeting agenda.

- (a) Board Member Responsibilities document-The committee reviewed this and had no changes for this document, which was last approved December 12, 2011. A Camp/Wilson motion to approve the document with no changes was approved by all.
- (b) Board Composite of Skills-This is an active document and should be available, password protected to Board members online along with other documents. While the race/ethnicity data is necessary, and we should be aware of all the factors, that column should be hidden, as it is unrelated specifically to skills. It was suggested that younger members are needed on the Board. We should think of people who will be great on the Board.
- (c) Board Member Recommendations list for FY 2023-2025-Rodney will review this.
- (d) Governance Committee Report- This highlights members rotating off and open positions, committee composition and leadership, and Board terms.

Kathy stated there are five Board positions opening due to the following Board members rotating off effective June 30, 2022 and one earlier resignation by John Holshouser. Rodney Reynolds, Felicia Hairston, Richard Jones, and Calton Weatherford complete their second term June 30, 2022.

Rodney presented the following list of six potential new board members who have agreed to nomination:

The director who made each recommendation will communicate with the nominee(s) to confirm their agreement to serve. Confirmation is needed by May 11, 2022.

Rodney emphasized the need to clean up the eight-page Potential Board List. It would be very helpful for all Board members to review the list, and provide staff with names that should be removed from the list. Alternatively, Richard Camp suggests an active list of perhaps ten names. Dave Zook, Mark Gignac and R.J. Weaver were mentioned as potentially strong members.

The Governance Checklist is a report listing significant, monthly governance related activities for each fiscal year. Rodney recommends adding the Board Planning Retreat to this list in August or October.

We need to identify two dates for planning the retreat prior to the event. A meeting in May is recommended. Use of the Danville Regional Foundation \$50,000 capacity-building grant is necessary.
